

PROFESSIONAL DEVELOPMENT/SCHOLARSHIP OPPORTUNITIES FOR WASHINGTON STATE TREATMENT PROVIDERS

Thank you for your interest in the professional development scholarship opportunities for Washington State treatment providers to attend the Basic and/or Advanced Problem Gambling Training Workshops June 22-25, 2015. The scholarships were established, with the support of Division of Behavioral Health and Recovery, to encourage and support participation by professionals who have applied to become a Washington State certified gambling counselor and hold a current certificate or license issued by the State of Washington to provide mental health or chemical dependency treatment services to the public.

Applications for certification are available online at www.evergreencpg.org or by calling the Evergreen Council on Problem Gambling at 360.352.6133. Treatment providers with applications on file by June 15, 2015, are eligible. A limited number of professional development scholarships are available (total value up to \$385) that will include:

- Full Basic or Advanced Workshop registration for June 22-25, 2015.
- Washington State Gambling Certification application fees (for those who have not yet applied).
- Hotel stipend of \$50 for up to two nights for any scholarship recipient who books his/her room at the designated training hotel (Red Lion Hotel - Pasco). Additional lodging costs, meals, and travel expenses are the responsibility of the attendee.

CONTINUING EDUCATION/CERTIFICATION

All Evergreen Council on Problem Gambling (ECPG) workshops qualify toward the 30 hours of gambling-specific education required by the Washington State and National Problem Gambling Certification Boards. ECPG is an Approved Provider of Continuing Education by The Association for Addiction Professionals (NAADAC) and the National Board for Certified Counselors (NBCC). Our workshops have also been approved for continuing education by the Addictions Counselor Certification Board of Oregon (ACCBO), the American Academy of Health Care Providers in the Addictive Disorders (AAHCPAD), and the National Association of Social Workers (NASW).

- ☑ Download registration form at www.evergreencpg.org and FAX or email to ECPG (scholarship recipients cannot complete registration form online). **Workshop registration MUST be sent in with scholarship application.**
- ☑ Have a completed Washington State problem gambling counselor certification application on file with ECPG by June 15, 2015, which is available at <http://bit.ly/13KR1IF>. All scholarship recipients must commit to completing the Washington State problem gambling counselor certification requirements within two years of certification application.
- ☑ Hold a current certificate or license issued by the State of Washington to provide mental health or chemical dependency treatment services to the public.
- ☑ Be a current ECPG member. Visit www.evergreencpg.org → **Membership** or fill out the form in this application.

AWARDS

Professional development scholarship recipients will be notified by June 17, 2015.

DEADLINE

Completed certification application form and supporting documentation—with a completed workshop registration form—must be postmarked by June 15, 2015. Applications received after this date will be considered only if funding is available.
