MONDAY, JUNE 22 - THURSDAY, JUNE 25, 2015 - BASIC TRAINING

8 am - 5 pm **BASIC PROBLEM GAMBLING COUNSELOR TRAINING, PART I** (Monday and Tuesday, June 22-23)

Presented by: **Oblio Stroyman, M.Ed, LMFT, QMHP, CGAC-II, NCGC-II, BACC**

BASIC PROBLEM GAMBLING COUNSELOR TRAINING, PART II (Wednesday and Thursday, June 24-25)

Presented by: **Colin Hodgen, PhD, LADC-S, CPGC-S, NCGC-II**

This 30-hour workshop serves as an introduction to problem and pathological gambling disorders. Participants will learn about the scope and prevalence of gambling and problem gambling on a national scale, risk factors, and how the increased availability of gambling over the past 10 years has affected the prevalence of gambling problems in the United States. The DSM-5 criteria for pathological gambling will be discussed, and participants will learn practical application of the most commonly used screening and diagnostic tools. This workshop outlines the types and sub-types of gamblers and several approaches to treatment of problem gamblers. Participants will learn about the disorders that most often co-occur with problem gambling and the effects of the disorder on family and loved ones. The two-hour Successful Records Management course will be taught by Cheryl Wilcox Wednesday morning from 8 am to 10 am. Basic Training also includes an overview of topic areas covered on the National Counselor Certification Exam. **Basic Problem Gambling Counselor Training is required for Washington State Gambling Counselor Certification.**

MONDAY, JUNE 22, 2015 - ADVANCED WORKSHOPS

8 am - 10 am **STATE OF THE STATE / STATE OF THE NATION**

Join Evergreen Council on Problem Gambling Executive Director Maureen Greeley as she shares the latest information in the world of problem gambling; from legislative efforts to technological developments, and the role treatment providers play.

10 am - Noon **SUCCESSFUL RECORDS MANAGEMENT**

Presented by: **Maureen Greeley and Cheryl Wilcox**

Record keeping is a real part of every counselor's job. This session will clarify what the requirements are for state- and ECPG-funded providers, and will provide tools to further your success. We will walk through a new client record from assessment to discharge and answer any questions you may have regarding Washington State WAC requirements and counselor responsibilities in record keeping and billing. Requirements for certification as a problem gambling counselor in the state of Washington will also be covered.

1 pm - 5 pm **MINDFULNESS AND ADDICTION**

Presented by: **Denise Quirk, MA, MFT, LADC, NCGC-II, CPGC-S**

Participants will take a journey into the history of mindfulness and how it has become an important psychological approach today. This session will discuss how mindfulness can be helpful in working to address addiction, and learn how to practice mindfulness with some basic techniques. Non-traditional and promising practices will also be discussed.

TUESDAY, JUNE 23, 2015 - ADVANCED WORKSHOPS

8 am - 10 am **FROM DSM-IV TO DSM-5: GAMBLING DISORDER**

Presented by: **Denise Quirk, MA, MFT, LADC, NCGC-II, CPGC-S**

This session will address specific changes in Substance Use and Related Disorders in the DSM-5, especially the newest and only behavioral addiction, Gambling Disorder. Application of this new chapter for practitioners who assess, diagnose, and treat individuals and families with addiction is imminent: DSM-5 will become a regularly-used tool in the diagnostic arsenal. The focus on Gambling Disorder in this presentation will leave the participants ready to apply DSM-5 after completion of this session's study and discussion.

10 am - Noon **THE GPPC, THE ASAM CRITERIA, AND LEVELS OF CARE IN TREATING GAMBLING DISORDER**

Presented by: **Denise Quirk, MA, MFT, LADC, NCGC-II, CPGC-S**

Understanding the new and relevant tools for proper assessment and placement of clients with Gambling Disorder and their family members is the focus of this presentation. The GPPC (Gambling Patient Placement Criteria) is a manual, similar to the ASAM PPC-2R, developed by Denise Quirk and colleagues to address a lack of guiding principles or tools for proper placement of gamblers. With the advent of the newly released "The ASAM Criteria" reference book, participants will enjoy exploring how to use these tools as they strive for excellence in treating gamblers and their families.

1 pm - 5 pm **PROBLEM GAMBLING AND DOMESTIC VIOLENCE: BEATING THE ODDS; BEATING THE FAMILY**

Presented by: **Colin Hodgen, PhD, LADC-S, CPGC-S, NCGC-II**

This session will review the current incidence/prevalence of Problem Gambling and Domestic Violence in the state of Washington and then describe the current climate of co-occurrence and linkage of these disordered behaviors. The session will provide concerned individuals with statutory resources and guidance as well as prevention, intervention, treatment, and social services resources. Special note will be made of the etiology and linkage of Problem Gambling and Domestic Violence, warning signs and indicators of the disorders, and risk factors for individuals and families.

CONTINUING EDUCATION/CERTIFICATION

All ECPG-related workshops qualify toward the 30 hours of gambling-specific education required by the Washington State and National Problem Gambling Certification Boards. The Evergreen Council on Problem Gambling is an Approved Provider of Continuing Education by The Association for Addiction Professionals (NAADAC) and the National Board for Certified Counselors (NBCC). Our workshops have also been approved for continuing education by the Addictions Counselor Certification Board of Oregon (ACCBO), the American Academy of Health Care Providers in the Addictive Disorders (AAHCPAD), and the National Association of Social Workers (NASW).

PRESENTER BIOS

MAUREEN GREELEY

Maureen Greeley has served as Executive Director of the Evergreen Council on Problem Gambling since November 2006, helping to broaden the Council's reach and strengthen its programs and services. She is currently the President of the National Council on Problem Gambling's Board of Directors. She has worked with and for the state and National Councils since 1998.

COLIN HODGEN, PhD, LADC-S, CPGC-S, NCGC-II

Colin Hodgen has a master's degree in Counseling and Educational Psychology (University of Nevada, Reno) with an emphasis in Addictions. He is a Nevada-licensed alcohol and drug counselor, and a Nevada-certified problem gambling counselor and supervisor. He has experience in psychoeducation and the screening, assessment, and placement of individuals with addictive disorders. Hodgen wrote and teaches an online course in aging and addictions for the University of Nevada, Reno, and is co-author of *Gambling Patient Placement Criteria*.

DENISE QUIRK, MA, MFT, LADC, NCGC-II, CPGC-S

Denise Quirk is certified as a clinical supervisor and gambling counselor specializing in treatment for families. She is the CEO and Clinical Director of the Reno Problem Gambling Center, a non-profit outpatient

treatment center. Denise created and teaches an online problem gambling course through the University of Nevada, Reno. She serves as a Board member for the Nevada Council on Problem Gambling and is a member of the Nevada Governor's Advisory Committee on Problem Gambling. She is co-author of *Gambling Patient Placement Criteria*.

OBLIO STROYMAN, M.Ed, LMFT, QMHP, CGAC-II, NCGC-II, BACC

Oblio Stroyman is a Licensed Marriage and Family Therapist in the state of Oregon, earning her M.Ed in Couples and Family Therapy from the University of Oregon, and holding a BS in Sociology and Women and Gender Studies. She has worked in the problem gambling field since 2006, holding CGAC-II and NCGC-II certifications. Primary areas of focus and passion for her work include working with couples and families in problem gambling and LGBTQI and diversity concerns.
