PROFESSIONAL DEVELOPMENT/SCHOLARSHIP OPPORTUNITIES FOR WASHINGTON STATE TREATMENT PROVIDERS

Treatment providers with applications on file are eligible. A limited number of professional development scholarships are available (total value up to \$694) that will include:

- Washington State Gambling Certification application fees (for those treatment providers who have not yet applied).
- Hotel stipend of \$75/night for up to 3 nights at the training hotel
- 1-year ECPG Associate for new Associates

CONTINUING EDUCATION/CERTIFICATION

- ☑ Be a current ECPG Associate. Visit www.evergreencpg.org → ECPG Associate or fill out the form in this application. If your scholarship application is approved, first-time Associate fee is waived.
- Have a completed Washington State gambling counselor certification application on file with ECPG which is available at https://wp.me/Pa672H-GS. All scholarship recipients must commit to completing the Washington State gambling counselor certification requirements within two years of certification application.
- Hold a current certificate or license issued by the State of Washington to provide mental health or substance use treatment services to the public.

DEADLINE

Completed application forms and supporting documentation—with a completed workshop registration form—must be postmarked by 10 days prior to the start of the training. Applications received after this date will be considered only if funding is available.

AWARDS

Professional development scholarship recipients will be notified within 14 days after receipt of the application packet.
